





Annual Report of the Public Service Commission West Bengal

For the year 2013-2014

(1st April '2013 to 31st March '2014)

PART I

GENERAL

As a body enshrined in the Constitution of India, the Public Service Commission, West Bengal, has sincerely remained active in discharging its constitutional duties and living up to its tradition as inherited from the Bengal Public Service Commission that was formed under the Government of India Act, 1935 and which started functioning with effect from April, 1937. A report on its working during the year 2013-2014 is set-forth hereunder.

1. The Commission and its composition

4. Functions of the Commission

The Constitution of India has enjoined consultation with the Public Service Commission on matters of appointment and certain other matters as specified in Article 320 in respect of the Civil Services and posts. The Public Service Commission has to perform the duties relating to matters

specified in that Article. These include conducting examinations for appointment to Civil Services and posts under the State Government and advising the State Government on all matters relating to methods of recruitment to Civil Services and posts, on the principles to be followed in making appointments to Civil Services and posts and in making promotions and transfers from one service to another, on the suitability of candidates for such appointments, promotions or transfers and on all disciplinary matters affecting a person serving under the State Government in a civil capacity and on certain other matters.

Article 229 and Article 234 also contain provisions in terms of which the Commission is required to be consulted in matters of appointment to certain categories of posts in offices attached to the High Court and to the State Judicial Service respectively. Besides, Acts made for certain statutory bodies contain provisions for consultation with the Commission in matters of appointment to certain categories of posts under such bodies. Article 321 also contains provision in terms of which additional functions may be entrusted to the Commission by an Act made by the State Legislature as respects the services of the State or any local authority or any body corporate or any public institution. Such an Act has, however, not been made till now.

The Commission is consulted by the State Government in making recruitment to a majority of Civil Services and posts. However, some posts under the State Government have been kept outside the purview of the Commission by making regulations in terms of the proviso to Article 320(3) of the Constitution. Such regulations are the West Bengal Public Service Commission (Exemption from Consultation) Regulations, 2008.

5. Workload of the Commission

A statistical account of the main items of work performed by the Commission during the year 2013-2014 is given in the following pages under the caption: **Workload at a Glance.**

During the period under report, the Commission held 735 sittings to interview and select candidates for direct recruitment to various services and posts. Altogether 6,057 candidates were called in for interviews. The Commission continued its practice of inviting experts of different disciplines to assist it in the matter of selection of candidates and thus it maintained liaison with various universities, institutions and organizations.

For direct recruitment by competitive examination with or without interview, the Commission held 08 (eight) different kinds of recruitment examinations including W.B.C.S. (Exe) etc: (Prel.) Examination, 2013, West Bengal Judicial Service (Prel.) Examination, 2013, West Bengal Judicial Service (Final) Examination, 2013, Miscellaneous Services Recruitment Examination (Prel.), 2012, W. B. C. S. (Exe) etc. (Main) Examination, 2013, W.B. Forest Service & W.B. Sub-ordinate Forest Service (Prel.) Examination, 2013, W.B. Legal Service Examination, 2013, W.B. Audit & Accounts Service (Spl. Rectt.) Examination, 2013. There were altogether 2,71,586 candidates applied, 2,69,568 candidates allowed and 1,86,614 candidates appeared for these examinations including 6,318 candidates admitted to the 03 (three) Main Examinations. During the year under report, the Commission allotted, 1,571 candidates including 345 Scheduled Caste, 65 Scheduled Tribe and 118 Backward Class candidates for appointment to different services and posts on the results of different recruitment examinations.

For direct recruitment through selection by interview (with or without preliminary written test) the Commission advertised 651 posts of different categories and received altogether 22,751 applications. Preliminary written tests were held for 21 categories of posts for the purpose of short-

listing of candidates. After selection, during the period under report, the Commission recommended 546 candidates including 135 S.C., 21 S.T., 94 B.C. and 06 P.H. candidates for appointment to different services and posts. The Commission also recommended another 04 candidates including 01 S.C. candidate for appointment to different services and posts from the reserve lists prepared on earlier selections.

For promotion, the Commission held 108 sittings to discuss the cases with the representatives of the concerned departments of the State Government. Altogether, 1,266 vacancies in different services and posts were reported to the Commission for being filled up by promotion. During the period under report, the Commission recommended 1,102 officers for promotion after considering cases of 3,771 officers and could not make any recommendation against 164 vacancies for reasons mentioned in Part-IV.

In disciplinary matters, during the period under report, the Government forwarded 67 cases (34 fresh and 33 old) to the Commission for advice. The Commission was able to tender its advice only in 22 cases, while the remaining 27 cases, were sent back to the Government asking for necessary papers/particulars and 18 cases were pending with the Commission till the closing of the year (i.e. 31.03.2014).

The Commission also tendered advice on framing of recruitment rules for 44 different categories of services and posts and on 02 cases regarding revision of examination rules.

During the year under report, the Commission held Half-yearly Departmental Examination in May and November, 2013 each time for 7 different categories of officers serving under the Government of West Bengal including those of I.A.S. probationers. The total number of registered candidates for the Departmental Examinations was 4,975.

Despite the fact that Commission performs its function according to the rules and regulations, the Commission was impleaded as a Respondent in a number of Court cases during the period under report. The cases were defended as per the rules and regulations as well as on the strength of records relating to the case. 118 fresh litigations, 01 in the Supreme Court, 57 in the Hon'ble High Court, Calcutta and 59 in the Hon'ble West Bengal Administrative Tribunal and 01 in the other Court were filed involving the Commission during the period under report, out of which 53 cases, 40 in the Hon'ble High Court, Calcutta and 12 in the Hon'ble West Bengal Administrative Tribunal and 01 in the other Court were contested by the Commission. Besides, 72 cases (including old pending cases), 02 in the Hon'ble Supreme Court, 61 in the Hon'ble High Court, Calcutta, 08 in the Hon'ble West Bengal Administrative Tribunal and 01 in other courts against the Commission are pending. Apart from the aforesaid cases, 36 cases, 17 in the Hon'ble High Court, Calcutta and 18 in Hon'ble West Bengal Administrative Tribunal and 01 in other Court (CAT) were disposed of during the period under report.

Table I intra gives previous and current years' figures on certain items of work.

6. OBSERVATIONS

A. *Requirement of consultation with the Commission regarding promotion:*

The Commission has noticed that the proviso to Article 320(3)(b) is being interpreted by many Departments of the Government that consultation with the Commission is not necessary for making promotion from one post to another where the posts are (i) within the same service and (ii) not belonging to any service (i.e. the posts of West Bengal General Service). The Commission is of the view that such interpretation would not be in consonance with the spirit of the Constitution. The Patna High Court in the case of Hariprasad Vs. State (AIR-1972, Patna-4) and the Supreme Court in the case of Jammu and Kashmir Vs. Rajdulari Rajdan and others (AIR 1979-SC-586 and 587) gave the judgement in favour of consultation with the Commission in all cases of promotions. It is mentioned in this connection that the Union Public Service Commission after discussion on the point at the National Conference of the Chairmen of the State Public Service Commissions, has sought an amendment to Article 320(3)(b) in its memorandum to the National Commission set up to review the working of the Constitution so that the scope of interpreting the existing expression in the Article is obviated and the Commission is consulted in making promotions from one post to another.

The Commission expects that the State Government would consider the matter and take steps so that the Commission is consulted in making promotions from one post to another in all cases.

B. *Reporting of vacancies to the Commission for various recruitment examinations:*

The Commission has been experiencing difficulties in obtaining estimates of vacancies from the Departments of Government in time. In some cases much delay occurs in reporting vacancies to the Commission despite urgent requests and repeated reminders. Consequently, holding of personality tests after the written examinations in the concerned cases gets deferred and finalization of results of the examinations is delayed. Often vacancies are reported long after the completion of personality tests. Such vacancies cannot be accepted for that particular examination and remain to be filled up on the results of the next examination. Needless to mention that an estimate of vacancies is necessary for the Commission to fix up the number of candidates for the personality tests and once the personality test is completed on the basis of the estimated record, further vacancies for the particular examination cannot be accepted.

The Commission feels that it may be possible for the Departments of the Government to make a forecast of vacancies to occur in a year due to retirement. Additional vacancies due to resignations and/or creation of posts can also be accommodated mostly by the time the estimate of vacancies is required for the personality test. Such procedure should be followed in the cases of annual recruitment examinations in view of the difficulties mentioned above.

An annual calendar of vacancies in the posts within the purview of the annual recruitment examinations may be prepared and maintained by the appointing authority so that an estimate of vacancies in the posts for the annual recruitment examinations could be furnished positively by the 31st of March of the year of the examinations taking into account the vacancies to be available by the 31st of December of that year.

C. *Disciplinary cases—Incomplete reference from Government Departments:*

The Commission reiterates its earlier observation that the disciplinary cases are mostly referred to it for advice without furnishing necessary documents and particulars. Such cases are therefore required to be sent back to the Departments concerned and thus it is unnecessarily delayed.

D. *Extension of Pre-examination Training Facilities:*

The Commission in its earlier annual reports tendered advice in favour of the extension of the existing facilities of pre-examination training of SC/ST candidates for various recruitment examinations. It is noticed that a good number of vacancies reported for these categories of candidates remained unfilled for want of suitable candidates, even after sufficiently lowering the general standard, during the period under report. The Commission suggests that the Government may consider opening training centres in various places in the State, especially in the tribal concentrated districts.

E. Departmental Examinations—Ensuring Appearance of the officers at the Examinations:

It has come to the notice of the Commission that quite a large number of officers whose cases are forwarded to it and who are admitted to these examinations do not appear at the examinations, causing much inconvenience to the Commission as also wastage of time and drainage of money. So, the Commission suggests that the officers applying for the Departmental Examinations should be instructed by the Departments/Offices concerned to appear at the examinations without fail.

Important particulars of the recruitment examinations held during the year 2013-2014 are as follows :—

(i) West Bengal Civil Service (Executive) Etc. (Preliminary) Examination, 2013 : Date of Examination—07.04.2013:

The examination was held in 17 centres throughout West Bengal including Darjeeling. Number of venues at different centres were as follows :—

Kolkata (North) — 50, Kolkata (South) — 36, Baruipur — 14, Barrackpore — 21, Barasat — 25, Howrah — 12, Burdwan — 18, Asansol — 6, Medinipur — 15, Tamluk — 7, Bankura — 8, Berhampore — 16, Malda — 15, Jalpaiguri — 9, Cooch Behar — 15, Siliguri — 15, Darjeeling — 4.

In all 1,06,851 candidates applied for the examination of whom 1,04,921 candidates were allowed to appear at the examination. Finally, 77,649 candidates appeared at the examination.

(ii) West Bengal Judicial Service (Preliminary) Examination, 2013 : Date of Examination—19.05.2013:

The examination was held at 3 venues in Kolkata and 1 venue in Darjeeling. In all 1,174 candidates applied for the examination of whom 985 candidates were admitted. 694 candidates took their examination.

(iii) West Bengal Judicial Service (Final) Examination, 2013 : Dates of Examination—20.07.2013 to 30.07.2013 (except 21st, 22nd & 25 July, 2013):

On the basis of the results of preliminary examination, 212 candidates were allowed to take the main examination held at the Examination Halls of P.S.C. of whom 187 candidates appeared.

(iv) Miscellaneous Services Recruitment (Preliminary) Examination, 2012 : Date of Examination– 04.08.2013:

The examination was held in 17 centres throughout West Bengal including Darjeeling. Number of venues at different centres were as follows:—

Kolkata (North) — 35, Kolkata (South)— 19, Baruipur— 11, Barasat — 22, Howrah— 09, Chinsurah—14, Burdwan— 14, Asansol— 6, Bankura—7, Medinipur— 10, Tamluk—6, Berhampore— 11, Malda— 10, Cooch Behar— 10, Jalpaiguri— 4, Siliguri— 8, Darjeeling—3.

Number of applications received was 1,41,823 of whom 1,38,871 were allowed to sit for the examination. Finally, 94,416 candidates appeared at the examination.

(v) West Bengal Civil Service (Exe.) etc. (Main) Examination, 2013 : Dates of Examination–28.10.2013 to 20.11.2013 (except 1st, 2nd, 3rd, 5th, 6th, 9th, 10th, 11th, 12th &14th November, 2013):

On the basis of the results of preliminary examination, 3,973 candidates were allowed to take the main examination held at 12 venues in Kolkata including the Commission's Examination Halls. 2,917 candidates appeared at the examination.

(vi) West Bengal Forest Service and West Bengal Subordinate Forest Service (Preliminary) Examination, 2013 : Date of Examination– 19.01.2014:

The examination was held at 20 venues in Kolkata, 3 venues in Siliguri and 1 venue in Darjeeling. In all 9,674 candidates applied for the examination of whom 8,643 candidates were admitted. 4,928 candidates took their examination.

(vii) West Bengal Legal Service Examination, 2013 : Dates of Examination– 17.02.2014 to 21.02.2014:

The examination was held at 7 venues in Kolkata including the Commission's Examination Hall. In all 2,234 candidates applied for the examination of whom 2,133 candidates were admitted. Finally, 606 candidates took their examination.

(viii) West Bengal Audit and Accounts Service (Special Recruitment) Examination, 2013 : Dates of Examination– 23.03.2014:

This was the first ever examination conducted by the Commission where applications were received online. The examination was held at 24 venues in Kolkata including the Commission's Examinations Halls and 3 in Siliguri. Number of candidates were 9,830 all of whom were allowed to sit for the examination. Finally, 5,217 candidates appeared at the examination.

Limited Departmental Examination

Limited Departmental Examination of eligible employees of the Govt. of West Bengal for promotion to the posts in the West Bengal Audit & Accounts Service, 2013: Dates of Examination–06.08.13, 07.08.13 and 13.08.13.

The examination was held at the Commission's Examination Hall at Kolkata. 311 candidates applied for the examination of whom 305 candidates were admitted. 183 candidates appeared at the examination.

8. Departmental Examinations :

During the year under report, Half-yearly Departmental Examination was held in May and November of officers of 7 (seven) different categories serving under the Government of West Bengal. In May, 2013, number of officers registered for the examination was 2,590 of whom 1,072 officers appeared. In November, 2013, the number of registered candidates and appeared candidates were 2,385 and 950 respectively. In May and November, 2012, the position was as follows—In May, registered candidates = 2,350 & Present candidates = 1,001. In November, registered candidates = 2,376 & Present candidates = 1,302.

The particulars are given in detail in **Appendix-I (E)**.

9. Adoption of unfairmeans by candidates in the examinations conducted by the commission :

During the year under report, 39 (thirty nine) candidates were reported against by the Supervisors of different examination centres for adoption of unfairmeans in various examinations conducted by the Commission. The particulars of the cases showing the nature of offences and the penal measures taken against them are given in **Appendix–VIII**.

PART-III
DIRECT RECRUITMENT

10. Recruitment after advertisement and interviews:

During the year under report the Commission considered the proposals from Government reporting altogether 655 posts of various categories for appointment, after advertisement and interviews for recommendation from the reserve lists. Details are given in Appendix-II (A) & Appendix-II (B) (synopsis) - 152 of the above posts were reserved for members of S.C., 53 for S.T., 111 for B.C. and 30 for P.H. candidates.

Regarding the 655 posts, as above, the Commission took action as follows—

- (a) 4 candidates including 1 SC candidate, recommended from its previous reserve lists.
- (b) Advertised the remaining 651 posts including 151 posts reserved for S.C., 53 for S.T., 111 for B.C. and 30 for P.H. candidates.

In response to the advertisements mentioned at (b) above 22,751 applications including 5463 from S.C., 746 from S.T., 2515 from B.C. and 121 from P.H. candidates were received.

The number of candidates called in for interview during the year under report was 2363 including 640 S.C., 107 S.T., 328 B.C. and 11 P.H. candidates. Out of whom 1858 candidates including 470 S.C., 91 S.T., 279 B.C. and 10 P.H. candidates appeared at the interviews. The Commission held 325 sittings during the year under report for interviewing the candidates.

Out of 651 posts advertised, the Commission recommended candidates for appointment to 546 posts including 290 for general candidates (9 S.C., 16 B.C & 01 P.H.. candidates ranked amongst the general candidates on merit were recommended against unreserved vacancies), 135 for S.C., 21 for S.T., 94 for B.C. & 06 for P.H. candidates. In respect of the remaining 105 posts including 16 reserved for S.C., 32 for S.T., 17 for B.C. and 24 for P.H. candidates, no candidate was available and hence the Commission could not make any recommendation. Of these posts 46 were teaching posts under Education Department and the remaining 59 posts were non-teaching posts requiring technical and/or professional qualifications.

In all, therefore, the Commission could recommend 550 candidates during the year under report including 136 posts reserved for S.C., 21 for S.T., 94 for B.C. & 6 for P.H. candidates—of which 04(3 UR & 1 SC) from its earlier reserve lists and 546 on the basis of advertisements issued by the Commission. During the year under report, Government dealt with the recommendations as follows :—

During the year under report 298 vacancies reserved for Scheduled Caste and 80 vacancies reserved for Scheduled Tribe Officers were reported to the Commission for being filled by promotion.

The Commission considered the cases of 308 SC & 64 ST Officers for promotion. Of them, the Commission recommended 187 SC & 36 ST Officers against the said reserved vacancies. During the year under report the Commission considered and tendered advice on 2 (Two) cases regarding revision of examination rules. All of them were finalised by Government during the year under report. Details are given in **Appendix-IV B**.

PART-VII

Disciplinary Cases

14. During the year under report 67 (sixty seven) cases were referred to the Commission for advice of which 34 (thirty four) cases were referred to the Commission for the first time and 33 (thirty three) cases which had been referred to the Commission earlier but returned for want of requisite documents

and other particulars related to those cases. On verification 27 (twenty seven) cases including some of the old cases were found wanting in relevant documents/particulars and were returned to the Government among which in one case the Govt. issued final order without receiving formal recommendation of the Commission. 18 (eighteen) cases were under examination of the Commission till the close of the year under report. The Commission in the process, could tender advice in 22 (twenty two) cases during the year under report details of which are shown in **Appendix-V**. In 18 (eighteen) cases the Govt. reported acceptance of the recommendation of the Commission and in one case the Govt. issued final order overriding the recommendation of the Commission. Regarding the remaining 3 (three) cases the decision of the Govt. has not been communicated to the Commission till the close of the year under report.

In the last years Annual Report 15 (fifteen) cases were shown pending with the Govt. for decision to be taken on the advice of the Commission. Subsequently, the Govt. intimated acceptance of the recommendation of the Commission in 11 (eleven) cases but the decision of the Govt. regarding the remaining 4 (four) cases has not been intimated till the close of the year under report.

Irregular Appointment

15. There was no case where the Government made irregular appointment to any post within the purview of the recruitment examinations conducted by the Commission during the year under report.

PART-VIII A

Irregularity in imposing penalty in Disciplinary cases

On scrutiny of the final order passed by the Personnel & Administrative Reforms Department imposing the penalty of withholding of last increment of the Charged Officer due on 01.07.2013 under rule 8(ii) of WBS (C. C&A) Rules, 1971 in connection with the case of departmental proceedings against one W.B.C.S. (Exe.) Officer initially referred to the Commission in January, 2013 it was

found that the aforesaid final order was made by the Government under the Personnel & Administrative Reforms Department unilaterally without having received any formal recommendation of the Commission. The Commission, therefore, treated that imposition of penalty as irregular.

PART-IX

Overriding Cases

16. (i) In October, 2009 the Government in the Land & Land Reforms Department moved the Commission for its advice regarding the disciplinary proceedings framed one SRO-II. The officer was proceeded against on a single count of charge that he motivately disposed of the order of LRTT No. 2919/03 (LRTT) by divesting a chunk of land in favour of the applicants without maintaining the executive norms of the Govt. although he was ordered only to consider the prayer of the applicants as per direction of the Hon'ble Justice.

The Commission found the officer guilty of the charge framed against him and recommended a major penalty of reduction of pay of the Charged Officer by 3 (three) annual increments till his retirement under rule 8(iv) of WBS (C. C & A) Rules, 1971 with further direction that the delinquent is entitled to get his normal increments from the reduced basic pay. The Commission also advised that the Charged Officer be debarred from promotion during the period of his undergoing the penalty without treating such debarment as penalty. In July, 2013 the Govt. in the Land and Land Reforms Department unilaterally issued a final order imposing upon the Charged Officer a lesser penalty of withholding of three increments of pay of his with cumulative effect alongwith a direction of debarment of promotion of the Charged Officer for the period of undergoing his penalty. The Commission took a serious view in such activity on the part of the Govt.

(ii) In May, 2012 the Finance (Audit) Department came up with a proposal for delinking all Group 'B' & Group 'C' posts from the purview of the Commission by making amendment in the West Bengal Public Service Commission (Exempt from Consultation) Regulation, 2008. The Commission desired to make direct recruitment to the services/posts under Group 'B' and Group 'C' which were traditionally under the purview of the Commission. Finance Department agreed to the proposal and issued notification No. 7335-F(P) dated 27.08.2012 followed by Personnel & Administrative Reforms Department notification No.1520 PAR(Gen.) dated 03.09.2012 by making amendment in the said regulation accordingly. After that the Finance (Audit) Department overrode the advice of the Commission and issued notification No. 7600-F(P) dated 20.09.2013 incorporating amendment in the West Bengal Public Service Commission (Exemption from Consultation) Regulation, 2008 to delink all Group 'B' and Group 'C' posts from the purview of the Commission without consultation with the Commission.

(iii) Notification No. 694-F(P) dt. 07.02.2014 incorporating amendments in the West Bengal Services (Recruitment to Clerical Cadre) Rules, 2010, issued with the Finance (Audit) Department notification No. 7165-F(P) dt. 01.07.2010, as subsequently amended by notification No. 9145-F(P) dt. 09.11.2012, has been issued by the Finance (Audit) Department overriding the advice of the Commission sent in its letter No. 97 PSC(S&R)/C-1/81(Pt. I) dt. 31.07.2013.

PART-X

17. Recruitment Rules/Service Rules :

During the year under report, the Commission has dealt with two (2) cases regarding Revision of Examination Rules and has tendered its advice to the Government. The Government till the closing of the year has finalized both the cases (vide **Appendix-IV-B**).

In short, during the year under report, the Government altogether finalized two (2) cases regarding Revision of Examination Rules out of two (2) such cases on which the Commission had tendered its advice, i.e. 100% of the total work.

Besides, the Commission, during the year under report, also tendered advice on framing of Recruitment Rules for forty four (44) different categories of services and posts from nine (09) different departments under the Government of West Bengal. In the previous year corresponding figures were thirty nine (39) and twenty five (25) respectively.

PART-XI

18. During the year under report total 517 (five hundred and seventeen) cases were received by S.P.I.O., P.S.C., W.B. under R.T.I. Act, 2005 soliciting various information. Amongst these R.T.I. aspirants, 19 (nineteen) made First Appeals to the Appellate Authority, P.S.C., W.B. as well. A good number of petitioners put forth multiple representations at times. The S.P.I.O. and Appellate Authority in the office of the P.S.C., W.B. responsibly accomplished the task of dispatching replies to all the information seekers within the time limit as specified under R.T.I. Act, 2005. It is worthwhile to mention that only 3 (three) R.T.I. cases were eventually referred by the information seekers to the West Bengal Information Commission for hearing which were duly attended by the R.T.I. officials of P.S.C., W.B. The judgements delivered by West Bengal Information Commission after those hearings were strictly adhered to by the S.P.I.O., P.S.C., W.B.






